(Revenue \$ ) Personal Services: More than 100 of the Organization's representatives personally visit thousands of blind persons each year. These representatives help with social service needs, personal ministries, and refer the blind to other agencies that can provide assistance.

(Revenue \$ ) National Camps and Other Direct Services: Coordinate with National Camps for Blind Children to send visually impaired children and adults to camps at various locations across the United States and Canada.
